Additional Protocol 5 provides for recognition of legislation and trade related inspections if those are aligned with the EU acquis. Alignment with the EU legislation is to be validated according to the procedures agreed between the Parties. Subsequently, several actions have been initiated aiming to simplify and streamline inspections and to reduce formalities to the maximum possible extent, but also to set the relevant procedures of validation. They are beneficial for both, business community and the competent authorities of the Parties, making trade less costly and more predictable. The panel will provide the opportunity to look closer into the current and future activities, with particular emphasis on trade in fruit and vegetables and industrial products. The system of electronic exchange of data will be presented as well, including the possibilities of introducing e-certificates leading eventually to paperless trade.

Following adoption of the Additional Protocol 6 on Trade in Services, CEFTA Parties have made a huge step towards free movement of services. Extensive commitments on market access and national treatment have already taken effect, shifting the emphasis on issues related to domestic regulation. The first on the CEFTA list of priorities are authorisations which are known by different names and forms: licenses, qualifications, permits, approvals, i.e. basically everything where businesses are required to get an approval before being allowed to supply the service. CEFTA has launched several initiatives which aim at simplifying business operations based on EU acquis, in particular Service Directive and Professional Qualifications Directive. The panel will zoom into these activities, as well as, discuss potentially new ones, seeking to further facilitate trade in service and bring Common Regional Market to life.

The panel will discuss the approach towards establishing a framework for furthering cooperation on IPR within CEFTA as part of the priorities of North Macedonia's 2021 CEFTA Chairmanship and the adopted actions under the Common Regional Market 2021-2024. This will be done through the findings and recommendations of the recent study that was completed under the CEFTA project on IPR that covers the assessment of the IP regulatory and institutional framework in CEFTA Parties in areas related to identified key trade barriers and untapped trade potential related to IPR, as well as the development of the CEFTA document that will set up the harmonised rules or minimum standards of legal protection in different areas of IPR, as well as enforcement rules taking into account EU and global (TRIPS) practices, while at the same time ensuring a closer cooperation among IP offices and other organizations dealing with IP in the region. The panel will also discuss and provide recommendations for potential areas of cooperation in the IP field between the EU and CEFTA Parties, namely those that could be implemented in cooperation with EUIPO.
